the **18th and 19th of January 2025**, bringing together a diverse group of delegates, Executive Board members, and dignitaries to celebrate the spirit of diplomacy and collaboration.

The opening ceremony commenced with the Worship of Goddess Saraswati. The ceremony was graced by the presence of esteemed dignitaries: Dr. Venkatadri M., Associate Dean, MPSTME Shirpur, Dr. S. S. Mungantiwar, MLA of Ballarpur, Maharashtra and K.C. Agnihotri, Deputy Commissioner of Jabalpur Division, recognizing the efforts of NMMUN in promoting a culture of diplomacy and leadership among the youth. His address highlighted the growing impact of NMMUN over the years as a platform for cultivating future leaders.

Avinash Tripathy, the Secretary-General of NMMUN'25, then addressed the gathering with an inspiring speech. He emphasized the importance of the discussions held within the committees and their potential to drive meaningful change. Avinash stressed that the power of dialogue and debate lies in transforming ideas into tangible actions that positively influence society.

As the opening ceremony drew to a close, the **Secretary-General formally declared the 16th edition of NMMUN open for the year 2025**, setting the stage for two days of dynamic discussions, powerful debates, and collaborative resolutions.

(United Nations Human Rights Council) UNHRC

Agenda: The impact of Economic Warfare Tools on the right to development and achieving the SDGs

NHRC brought to light critical issues affecting global stability and development. On **Day 1**, the delegates engaged in an intense discourse surrounding the impact of sanctions and economic warfare. Developed nations presented sanctions as necessary tools for ensuring accountability in governance, while representatives from underdeveloped countries shed light on the humanitarian consequences these sanctions impose, such as widespread poverty and limited access to essential resources. This divide sparked passionate debates on fair and sustainable solutions, reflecting the diversity of perspectives within the council.

On **Day 2**, the committee focused its efforts on addressing the ongoing humanitarian crisis in Sudan. After rigorous discussions and negotiations, an amendment was passed urging a ceasefire, ensuring unhindered humanitarian access, and promoting accountability mechanisms. The resolution also emphasized the need for an inclusive political dialogue to address the root causes of the conflict. The council's deliberations showcased a united commitment to upholding human rights and fostering sustainable development amidst global challenges.



The deliberations also shed light on the importance of regional cooperation and capacity-building initiatives in developing countries. Delegates called for strengthening partnerships with NGOs, regional organizations, and local governments to create sustainable solutions. This approach was pivotal in bridging the gap between the global north and south, ensuring equitable participation in global decision-making processes.

Historical Crisis Committee (HCC)

The offered a unique platform to revisit and analyze historical conflicts. On **Day 1**, delegates embarked on a deep exploration of the Iraq crisis, dissecting the political, military, and economic complexities that marked this pivotal moment in history. Topics ranged from the implications of weapons of mass destruction (WMDs) to the intricate power dynamics among global players. Delegates worked collaboratively to propose diplomatic solutions to resolve these historical tensions, exemplifying the essence of crisis management.

On **Day 2**, the committee expanded its focus to include additional historic crises that shaped the global political landscape. Delegates engaged in strategic debates and employed innovative

approaches to address these crises, leveraging historical hindsight. The sessions emphasized the importance of collaboration, negotiation, and adaptability in influencing historical outcomes, underlining the vital lessons these past events hold for present-day diplomacy.



The committee's unique approach to recreating historical scenarios allowed participants to analyze the consequences of critical decisions made by leaders of the past. By simulating alternative strategies, delegates gained a deeper understanding of historical contexts, fostering a sense of accountability and encouraging future policymakers to consider the long-term implications of their decisions.

Disarmament and International Security Committee (DISEC)

Agenda: Reducing the risk of Militarization of Outer Space

DISEC tackled the pressing and futuristic issue of militarization in outer space. On **Day 1**, delegates debated the increasing risks posed by anti-satellite (ASAT) weapons, the growing challenge of space debris, and the lack of robust international frameworks for space governance. References to foundational treaties like the Outer Space Treaty set the tone for developing collaborative solutions. Discussions highlighted the urgent need for a comprehensive framework on space traffic management and demilitarization.

On **Day 2**, the committee pivoted toward ensuring that outer space remains a peaceful domain for humanity. Delegates proposed measures to enhance transparency in space activities, promote equitable access to space technologies, and foster international partnerships. The discussions culminated in the adoption of resolutions advocating for peaceful cooperation and innovation in space exploration, emphasizing the critical role of global unity in preventing the weaponization of outer space.



The committee also recognized the importance of empowering developing nations to participate in space activities. Proposals were made to provide technical assistance and funding to underdeveloped nations, ensuring inclusivity in space exploration. This initiative emphasized the need for equitable access to space technologies, fostering global collaboration for peaceful purposes.

United Nations Office on Drugs and Crime, (UNODC)

Agenda: Addressing the shortcoming in the UNTOC and its supplementary mechanisms in the effective addressal of organized crime with special emphasis on money laundering and piracy

UNODC addressed multifaceted issues under the United Nations Convention against Transnational Organized Crime (UNTOC). On **Day 1**, delegates explored innovative mechanisms to combat money laundering, cybercrime, and organized crime. Proposals included the adoption of blockchain technologies to enhance financial transparency, the establishment of global monitoring bodies to track illicit financial activities, and the strengthening of international legal frameworks for cooperation.

On **Day 2**, the discussions delved deeper into resolving maritime disputes and empowering weaker nations to safeguard their territorial integrity. Delegates proposed using advanced technologies to bolster global unity in combating organized crime and ensuring financial transparency. The committee's comprehensive approach highlighted the importance of capacity-building for underdeveloped regions and the need for collective efforts to achieve peace and security in a rapidly evolving global landscape.



The UNODC also emphasized the importance of education and public awareness campaigns in combating organized crime. Delegates proposed initiatives to engage local communities, especially youth, in understanding the risks of criminal activities and the benefits of legal reforms. This strategy aimed to create a sustainable, grassroots approach to tackling crime and fostering societal resilience.

Lok Sabha

Agenda: Discussing the Constitution (one hundred and twenty-Ninth Amendment) Bill, 2024 and Union Territories Laws (Amendment) Bill, 2024

Lok Sabha committee sessions were marked by fervent debates and contrasting viewpoints on the "**One Nation, One Election**" proposal. On **Day 1**, prominent figures such as Jyotiraditya Scindia and Prime Minister Narendra Modi advocated for synchronized elections, citing benefits like streamlined governance, reduced election expenses, and minimized disruption of administrative activities. Their arguments underscored the potential for enhanced efficiency in governance through this reform.

On **Day 2**, opposition voices, including Rahul Gandhi, raised serious concerns about the potential erosion of federalism and regional representation. They argued that the centralization of power could marginalize regional interests and weaken the democratic diversity that defines India. The committee's heated discussions showcased the delicate balance between administrative efficiency and the preservation of India's democratic ethos, providing an enriching experience for the delegates involved.



The committee also touched upon the financial implications of implementing simultaneous elections, with experts presenting cost-benefit analyses. This discussion added depth to the debates, providing delegates with a holistic understanding of the proposal's practicality, economic feasibility, and long-term impact on the country's democratic framework.

Union of European Football Associations (UEFA)

Agenda:

1. Discussion on the Financial Fairplay AND Club Sustainability.

2. Discussing the fixture congested schedule of European competitions in club and country format from the 2024-2025 season.

UEFA committee tackled some of the most pressing challenges in European football governance. On **Day 1**, discussions revolved around loopholes in Financial Fair Play (FFP) regulations, the growing issue of fixture congestion, and the need to promote youth development in European football. Delegates worked diligently to identify solutions aimed at fostering a level playing field while ensuring the financial sustainability of clubs.

On **Day 2**, draft resolutions were introduced addressing two critical aspects: the strengthening of FFP regulations to enhance transparency and fairness, and the mitigation of fixture congestion by prioritizing player welfare and fan engagement. The resolutions highlighted the committee's commitment to reforming European football's governance, ensuring the sport's integrity, and promoting sustainable development for future generations.



The committee also emphasized the importance of enhancing grassroots football programs to develop young talent and bridge the gap between amateur and professional levels. Delegates proposed collaborations with local clubs, schools, and NGOs to make football more accessible, highlighting the committee's dedication to the holistic growth of the sport.

International Press (IP)

IP played an integral role in documenting the proceedings of NMMUN'25. On **Day 1**, the IP captured pivotal debates across committees, offering unbiased coverage of discussions in Lok Sabha on Jammu and Kashmir's statehood and the "One Nation, One Election" proposal. They hosted a press conference that facilitated dialogue between committee representatives and the press, adding depth to their reporting.

On **Day 2**, the IP focused on key developments in UEFA, DISEC, and UNODC. Their coverage provided insights into UEFA's resolutions on FFP reforms, DISEC's efforts to foster peaceful

collaboration in outer space, and UNODC's initiatives against organized crime. By maintaining journalistic integrity and delivering timely updates, the IP showcased the power of media in shaping public understanding of global issues.



The IP team also produced creative content, including exclusive interviews with delegates and satirical op-eds, adding a dynamic and engaging perspective to the sessions. This multifaceted approach demonstrated the pivotal role of journalism in fostering transparency and accountability in diplomacy.
