Refund Rules: The Schedule of refund of fees will be as follows as per UGC rule October 2018 - Extract:

If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution concerned shall follow the following system for the refund of fees remitted by the student.

| Sr. No. | Percentage of Refund of Aggregate fees* | Point of time when notice of withdrawal of admission is served to HEI  |
|---------|---|--|
| (1)     | 90%                                     | Less than 15 days before the formally-notified last date of admission. (i.e. from on or before 17 <sup>th</sup> July 2019)                               |
| (2)     | 80%                                     | 15 days or less after the formally-notified last date of admission (i.e from 18 <sup>th</sup> July 2019 to 1 <sup>st</sup> August 2019)                  |
| (3)     | 50%                                     | 30 days or less, but more than 15 days, after formally-notified last date of admission (i.e 2 <sup>nd</sup> August 2019 to 16 <sup>th</sup> August 2019) |
| (4)     | 00%                                     | More than 30 days after formally-notified last date of admission (i.e from 17 <sup>th</sup> August 2019 onwards)   |

\*(Inclusive of course fees and non-tuition fees but exclusive of caution money and security deposit)

In case of (1) in the table above, the deduction will be 5% of the fees paid as processing charges from the refundable amount, subject to a maximum of Rs 5,000/-.
